

Paying your car tax online

To renew your tax, please ensure that you have the following details:

- Vehicle Registration Number
- Name of Insurance Company (not the broker)
- Insurance Policy Number
- Date of Expiry of Insurance
- Payment Details

1. Type www.motortax.ie into your internet browser

2. Left click on the Motor Tax section.


